

This collection has 644 books in 41 boxes covering RI/Mass history, early records and genealogical topics. That count does not include the NEHGR collection.

A complete set from Volume 1 (1847) through Volume 118 (1964) of the original "The New England Historical & Genealogical Register" originally by Rev. William Cogswell, D.D., editor, Samuel Drake, Publisher, Boston. Each volume is bound into a book 6" x 9 1/2" x 1 1/2" wide. This encompassed 121 books in 13 boxes (BX_4001 to BX_4013 inclusive).
